

## WHAT ARE THE RACINE WORKS PROGRAM (RWP) CERTIFICATION REQUIREMENTS?

All RWP certification applicants MUST:

- Currently live within the City of Racine. To check City of Racine residency, visit: www.gis.cityofracine.org/RacineGIS.
- Classify themselves as either underemployed (worked less than 1200 hours in the past 12 months) or unemployed (laid off for the last 15 consecutive days).
- → Be an apprentice or journeyman OR must have completed a recognized pre-apprenticeship program. (WRTP | BIG STEP, First Choice, etc.).

I KNOW OF SOMEONE WHO IS ELIGIBLE FOR THE RACINE WORKS PROGRAM AND WOULD LIKE TO GET THEM CERTIFIED FOR MY PROJECT.

 $\mbox{\bf STEP 1.}$  Contact WRTP | BIG STEP to complete an initial screening for eligibility.

**STEP 2.** If the individual is determined to be eligible for RWP certification, WRTP | BIG STEP staff will work with you and the individual to complete the certification process. (See the certification process flyer for more information.)

**STEP 3.** Upon completing the certification process, WRTP  $\mid$  BIG STEP will provide you with copies of the RWP certification for your records.

\*\*Note: The individual MUST be RWP-certified before starting work on the City of Racine project in order for you to count the hours worked toward the Racine Works Program.\*\*

## I NEED HELP FINDING SOMEONE WHO IS CERTIFIED BY THE RACINE WORKS PROGRAM FOR MY PROJECT.

**STEP 1.** Contact WRTP | BIG STEP if you are struggling to locate individuals who meet the RWP certification requirements.

\*\*Union Contractors: It is important to first check-in with any of your affliated unions for RWP-certifed or RWP-eligible candidates.\*\*

**STEP 2.** WRTP | BIG STEP will have you complete a Job Order Form that will outline the details of your position and all requirements.

**STEP 3.** Submit your complete Job Order Form to WRTP | BIG STEP staff.

**STEP 4.** WRTP | BIG STEP staff will screen RWP certified participants and locate individuals who meet your workforce needs. Your company name is kept confidential during this process.

**STEP 5.** Once interested and eligible candidates are located, WRTP | BIG STEP staff will provide you with resumes for review.

**STEP 6.** WRTP | BIG STEP staff will work with you to set up interviews with candidates you would like to move forward with.

**STEP 7.** Once a candidate is hired, WRTP | BIG STEP will provide you with all RWP certification documentation for your records.

\*\*Note: The individual MUST be RWP-certified before starting work on the City of Racine project in order for you to count the hours worked toward the Racine Works Program.\*\*
