On 5/20/2022 at approximately 1301 hours I heard Officer Brenner via radio announce that he had been involved in a shooting incident. Myself and several other SIU members responded to the area of the 900 Blk. of Carrol St. where the incident had occurred.

Once we arrived to the 900 Blk. of Carrol St, the scene was already secured with RAPD, Mount pleasant and RCSO officers and crime scene tape. I made contact with Sergeant Comstock who was presently supervising the shooting scene and arranging other personnel to block streets etc in anticipation for another jurisdiction or agency to begin the investigation. Sergeant Comstock stated he was "ok" and didn't need any assistance or relief. Sergeant Comstock advised that Officer Brenner had initiated a traffic stop, the suspect fled on foot and Officer Brenner had chased the

suspect to the 900 Blk. of Carrol St. where the Officer involved shooting took place.

Sergeant BeBow and I shortly thereafter then left the scene by assisting with transporting officers and investigators to their secondary assignments of SWAT and Crowd control duties.

I was then contacted by Deputy Chief Toeller who advised that he wanted me to assist with the exchange of Officer Brenner's duty weapon. I notified Lieutenant Freidel and Sergeant BeBow of the request. Lieutenant Freidel stated he already was working on this process. I then stood by while Criminalist Hoover took photographs of Officer Brenner's complete duty uniform, firearm, magazine and extra duty magazines. These magazines were photographed individually and the rounds were removed from the magazines and counted in the the presence of Lieutenant Freidel, Sergeant BeBow, Officer Brenner, Criminalist Hoover and myself. See Lieutenant Freidel, Sergeant BeBow and Criminalist Hoovers reports for those details. My body worn camera was activated for this process.

I was then requested by Deputy Chief Toeller to begin the blood draw process for Officer Brenner. I requested Sergeant BeBow assist with this process. I made contact with Ascension hospital director Robert Lesko who advised that we should respond to Ascension Hospital in Franklin for the blood draw process. Officer Brenner was transported to the hospital for this procedure by Investigator Groth (RPA representative), Officer Burinda (RPA representative) and Officer Nabors. Sergeant BeBow and I followed the officers to the hospital in a secondary vehicle. Upon arrival to the hospital, I read the required paperwork and Garrity warning to Officer Brenner. The blood draw was complete by hospital staff and once completed they turned over the secondary blood draw kit to me. I then returned to the police department evidence packaging room and with the assistance of Sergeant BeBow inventoried the secondary blood draw as required by RAPD Policy 615. The paperwork was then placed into a sealed envelope and turned over to the Internal affairs unit as required.

Once back at the police department we were advised to assign SIU members to various locations throughout the City to monitor for any potential civil disturbance potential. There was nothing notable that occurred that evening and we were later released from the assignment.

On 05/20/2022, I, Sergeant (SGT) JEFFREY BEBOW #1916, was at my office performing my daily Police duties. I heard over the Police radio a traffic stop, which turned into an Officer foot pursuit, and eventually an Officer involved shooting. Based on the information that I received, I gathered my equipment and my department issued vest, which was contained in a tactical carrier, and responded to the scene to assist in any way possible.

Upon my arrival to the scene, which was located in the 900-block of Carroll Street, I observed that the scene was taped off with Police tape. I entered the scene and approached SGT RYAN COMSTOCK who was the current incident commander for the incident. I asked SGT COMSTOCK if he needed assistance in any way and SGT COMSTOCK advised that he did not need assistance at this time. SGT COMSTOCK advised that the scene of the incident was within a field on the southside of the 900-block of Carroll Street. SGT COMSTOCK did advise that a handgun, which the suspect did have, was located within the field. I was advised that the incident was indeed an Officer involved shooting and the suspect in this incident had died from his injuries. Based off of the information obtained, I was aware that the incident would be investigated by another agency. I was later advised that DCI-DOJ would be investigating the incident. I did not participate in the investigation into the incident; however, I did remain on-scene in case I was needed with crowd control assistance or any other assistance that may be needed. Due to the fact that the weather conditions were such that it was overcast with a possible chance of thunderstorms, I did assist with placing a pop-up tent over a portion of the incident scene. This was in an effort to prevent the scene from being washed out should a thunderstorm come through the area.

I then assisted with transporting personnel to secondary assignments (SWAT and Crowd Control). Once I had completed this task I was requested to respond to the Racine Police Department. Once at the Racine Police Department, I made contact with Lieutenant (LT) HANNS FREIDEL. LT FREIDEL requested that I witness the photographing of Officer (OFC) ZACHARY BRENNER and the inspection of his equipment. It should be noted that OFC BRENNER was identified as the

Officer involved in the shooting incident.

At about 1518 hours, myself, LT EDWARD IDE, LT FREIDEL, and Criminalist (CRMLST) TODD HOOVER made contact with OFC BRENNER in CRMLST HOOVER's office. At that time, CRMLST HOOVER did take photographs of OFC BRENNER and his equipment. OFC BRENNER also turned over his department issued handgun and it was inspected and photographed. I did witness the inspection and the photographs. Upon removing the magazine from OFC BRENNER's handgun, it was found that there was appendic live round in the chamber of OFC BRENNER's handgun and live rounds in the magazine that was in the handgun. LT FREIDEL also took

possession of the magazines that were located on OFC BRENNER's carrier. The rounds were removed from each of these magazines (two magazines) and each magazine contained

live rounds. LT FREIDEL then issued a new handgun with three (3) full magazines to OFC BRENNER. The photographs, inspection, and round count were captured on my body worn camera.

I was then requested by LT IDE to respond with him to Ascension Hospital in Franklin to witness the blood draw of OFC BRENNER. LT IDE and I then responded to Ascension Hospital in Franklin. It should be noted that we did follow OFC BRENNER who was being transported by INV NICHOLAS GROTH and OFC WILLIAM BURINDA.

Once at Ascension Hospital in Franklin, LT IDE, INV GROTH, and OFC BURINDA followed OFC BRENNER into a patient room. At about 1625 hours, the process for the blood draw began. I stood by while LT IDE conducted the blood draw with the assistance of the medical staff at Ascension Hospital. Once the blood draw was complete, we then responded back to the Racine Police Department. LT IDE property inventoried one of the blood collection kits into the BEAST system and the kit was secured in the Racine Police Department temporary evidence refrigerator. That concluded my involvement with this incident.



On Friday May 20, 2022 at approximately 1310 hours, INV. N. LOFY and I were conducting follow up related to an ongoing homicide investigation that occurred in the City of Racine on May 15, 2022. While out on this follow up, we heard an officer call out a traffic stop with a male running. Shortly after this was called out, there was a call of shots fired with one down on Carrol Street. Based on the severity of the call, INV. LOFY and I responded to the area to assist as needed.

Upon responding to the area of 12th Street and Schiller Street, I could see the area had already been taped off by patrol officers, so we parked our squad car outside of the crime scene tape and entered the scene on foot from 12th Street, walking to the east. I spoke with SGT. GARCIA who was in the driveway of 910 12th Street. SGT. GARCIA was next to a gray or silver colored Volkswagen SUV that he stated was associated with the suspect, and this car had the driver's door open. SGT. GARCIA advised me that they (Officer and the suspect), were "up there" and he pointed towards a grass lot area towards the north. At this time, I made my way on foot towards the north and climbed a small embankment with concrete and grass, into a large grass lot on Carrol Street.

Upon arriving in this area, I observed SGT. COMSTOCK, INV. SCARVERS, OFC. R. TREDO, OFC. M. JOHNSON and DC TOELLER in the area, as well as Racine Fire/Rescue personnel working on a black male who was shot. I did not immediately recognize the suspect upon looking at him. INV. SCARVERS pointed out a firearm in the grass a couple of feet from where the victim was lying on the ground, so I went to retrieve an evidence placard to mark the items of evidence that were on the ground. I was able to locate an orange traffic cone that I set on the ground next to the suspect's firearm, to prevent anyone from stepping on it, and to mark it's clear location for processing of the scene. OFC. JOHNSON then opened the Evidence Technician vehicle and I was able to retrieve the evidence markers. I replaced the orange cone with marker #1, and also marked some clothing that Rescue workers had cut off of the victim, as #2 and a bloody medical bandage

as #3. Racine Rescue workers had left some first aid materials on scene, and due to the wind these items were blowing all around, so Rescue personnel asked if they could pick the items up. I advised them to only pick up the loose medical medical wrappers/items that were on the ground which they did. OFC. M. JOHNSON did snap some photos of these items prior to them being picked up by Rescue.

After the scene was secured, INV. CONTRERAS and I made attempts to determine who was responsible for the vehicle in an attempt to positively identify the suspect who was shot. INV. CONTRERAS was able to contact Enterprise Rental and confirm that the vehicle was rented through their company. INV. CONTRERAS also learned that the renter of the Volkswagen was identified as **Contrel Contre** INV. CONTRERAS was able to get a contact number for and he placed a call to her. **Contre** advised INV. CONTRERAS that she did not know who had the vehicle she rented. We then learned that there was a male near the scene, identified as **Contre**, who was claiming he heard it was his **Contre** that was shot. I know based on my position in the Special Investigations Gang Unit - FBI Task Force that

to be DASHONTAY KING, aka "Day Day". Having this information, I looked up DASHONTAY KING in Racine County Phoenix records, and located a photo of DASHONTAY, who I did believe to look like the suspect. I observed in the photo that DASHONTAY had a large "YOLO" tattoo on his neck, so I made contact with INV. SCARVERS who was now at the hospital, to ask about the tattoo. INV. SCARVERS did confirm through INV. BLACKMORE that the suspect had a "YOLO" tattoo on his neck. INV. SCARVERS also advised me that the suspect had just been pronounced deceased. Based on the tattoo information, this assisted in confirming the identity of DASHONTAY KING, as the suspect in this investigation. INV. BLACKMORE also advised that it appeared DASHONTAY had three gunshot wounds to his right side/torso area. I also learned while on scene that the suspect vehicle (Volkswagen) was part of an investigation and there was a valid search warrant for the vehicle related to firearms.

We stood by the scene to secure it as a decision was being made on what outside jurisdiction would be handling this investigation. I deactivated by body camera at thirty three minutes and forty seconds on scene, to place a phone call. After the call ended, I was advised that the Crowd Control Team was being placed on standby and to report to the Racine PD to stage until we would be needed. I did respond to the Racine PD auditorium as standby for Crowd Control until released later that evening. This concluded my involvement in this incident.

NARRATIVE

On May 20, 2022, I, Investigator (INV) KEVIN KUPPER, was working at the Special Investigations Unit (SIU) Office when I heard radio transmissions of a vehicle stop and foot pursuit. Upon further radio transmissions, I learned Officer (OFC) ZACHARY BRENNER had been involved in an Officer involved shooting (OIS) during this incident.

Moments later I left the SIU Office in an unmarked Police vehicle along with Lieutenant EDWARD IDE and Sergeant (SGT) JEFFREY BEBOW. I was dressed in plain clothes wearing a Police marked T-shirt and ballistic vest contained in an external carrier with "POLICE" markings on the front and rear panels of the vest and Racine Police Department (RAPD) issued badge.

I responded to the 900-block of Carroll Street and entered the exterior crime scene tape. I did observe the area to be already marked with yellow crime scene tape on all sides and several Officers posted keeping onlookers away from the crime scene. I entered the interior crime scene and met SGT RYAN COMSTOCK who was the on-scene supervisor. I did observe placards in the grassy area marking what I believed to be a semi-automatic handgun, as well as clothing items.

Due to the threat of severe inclement weather, I assisted Criminalist TODD HOOVER (and other Officers) with setting up and moving a protective tent over the mentioned placards and items of evidence. After assisting with placing the tent I did move away from the interior crime scene as I believed DCI would be responding to take over the investigation due to the OIS incident.

Shortly after assisting with the tent, I was asked to return to RAPD to assist with SWAT responsibilities, as well as Racine Police Association responsibilities with OFC BRENNER. SGT BEBOW provided transport back to RAPD and I had no further involvement at the crime scene.

Once at RAPD, I did briefly speak with OFC BRENNER explaining the OIS investigation process and answering questions regarding RAPD policies and guidelines pertaining to the OIS investigation process, along with other RPA officers.

I then remained at RAPD to assist with SWAT responsibilities.

SUMMARY

This is a supplement to the original case report. My Body Worn Camera was activated during portions of the involvement in this case. On 05/20/2022, as I started my shift with the 2nd Shift General Investigations Bureau, I was notified that we had an Officer Involved Shooting. I also received information that the Officer Involved Shooting began as a traffic stop near 12th Street and Schiller Street, where a suspect fled from the vehicle. During the foot pursuit, Racine Police Department Officer ZACHARY BRENNER did shoot the suspect. At this point, I went to the scene and got further information from On-Scene Supervisor Sergeant RYAN COMSTOCK. Sergeant RYAN COMSTOCK was able to tell me that the suspect did in deed run from a vehicle, produced a handgun, at which time, Officer ZACHARY BRENNER gave several commands for him to stop and drop the gun. I was also told that Officer ZACHARY BRENNER did fire his service duty firearm, striking the individual. It was believed that the injuries sustained were critical. I then notified Lieutenant (LT) HANNS FREIDEL of the incident. Knowing that an Officer Involved Shooting that happens within our jurisdiction would require an outside agency to conduct the investigation, I directed our resources, in particular the Investigators that I supervise, to conduct scene security at the scene, as well as scene security at the hospital. Once I was done with scene security and management, I did provide rolling surveillance around City Hall, Racine County Sheriff's Office, the Courthouse, Racine Police Department, and Monument Square. There was no occurrences that demanded me to continue this detail and after several hours I was released from that assignment.

On 05/20/2022, I, Sergeant (SGT) ROBERT ORTIZ, began my shift as the Supervisor of the General Investigations Bureau at approximately 1300 hours. Shortly after, I received information from an Investigator that there was an Officer Involved Shooting (OIS). I continued to gather information and discovered there was a traffic stop at 12th Street and Schiller Street in the City of Racine. During this traffic stop, a suspect had exited the driver side door and ran from Officer (OFC) ZACHARY BRENNER. During the foot pursuit, the suspect was shot by OFC BRENNER. At this time, this was about all the information that I had.

I then drove to the scene and spoke with SGT RYAN COMSTOCK, who had been the Incident Supervisor up until that point. SGT COMSTOCK was able to confirm the Officer that fired his duty weapon was in deed OFC BRENNER. SGT COMSTOCK went on to tell me that OFC BRENNER conducted a traffic stop near the 12th Street and Schiller Street area, at which time the driver of the vehicle that was getting pulled over, pulled into a driveway, exited the vehicle, and began to run north from their location. The suspect was pursued by OFC BRENNER. The suspect made it to a grass area, located near Carroll Street. OFC BRENNER gave several commands for the suspect to stop, at which time the suspect did produce a handgun and OFC BRENNER fired several shots, striking the suspect. Life giving measures were attempted; however, SGT COMSTOCK believed that the injuries were critical. Rescue had already transported the suspect by the time I got on scene. I then took time to call LT FREIDEL, who I knew was not working due to an off day. I advised him of the OIS and the details that I knew up to that point. Several Investigators were on scene and worked in conjunction with Investigators that had already been over at the hospital and the suspect was identified as DASHONTAY KING. Moments later, the hospital advised

Investigators, who advised myself, that KING did pass away from his injuries.

While on scene, the forecast had said that it was possibly going to rain. While on scene, it did begin to drizzle and I was concerned that potential evidence might be altered or destroyed. I then contacted Criminalist TODD HOOVER and had him bring the Major Crimes van out and bring a large tent to cover the area where evidence was known to be located. Criminalist HOOVER did arrive and with the assistance of several Investigators, we were able to put a 12x12 tent over several items of evidence. OFC MATTHEW JOHNSON, along with Criminalist HOOVER, did take overall pictures in each direction of the scene where KING was shot. It should be noted that OFC DENNIS CECCHINI did have his K9 dog and attempted to locate casings. He was unable to locate any during my time on the scene. I then advised SGT COMSTOCK that OFC CECCHINI should stop canvassing the area for casings and that no one else should go over by the scene, due to the fact that I knew an outside agency would be conducting the investigation.

I then heard over the radio, LT WALTER POWELL saying that there was a large group gathering at the hospital. I knew that we had some Police personnel there, but I was worried that we would need more. I then advised all of the Investigators that were on the scene to make their way to the hospital to assist with crowd control.

After the scene was secured by Racine County Sheriff's Office (RASO) Deputies, SGT COMSTOCK said that he would no longer need my presence at the scene.

I proceeded to go to the Command Post and speak with Deputy Chief RICHARD TOELLER and LT MICHAEL SMITH. I advised them of what I had conducted so far and told them that I would be at the Racine Police Department (RAPD) waiting further instructions for my assistance.

While at RAPD, I was contacted by LT SMITH who advised there was a potential for gatherings either at the scene or near the scene that needed to be monitored. I then contacted Investigator (INV) MATHIAS ZINNEN and INV ALICIA MITCHELL, as well as INV TONYA SCARVERS. I advised them that we needed to do surveillance around several key points in the City, including, but not limited to, Monument Square, the Courthouse, RASO, City Hall, RAPD, and the actual scene of the incident.

JASON BACLAWSKI to our detail of rolling surveillance.

I was then contacted by LT MARK ESCH who advised there was an individual that may be trying to put together a group by the scene that needed to be monitored for crowd control. I did locate a party by the name of standard standing at the corner of 12th Street Franklin Street. It should be noted that the area was blocked off and he could not make it any further, but was about a block to a block and a half away from the actual scene. He was seen with a loud horn and with three to four people with him. I did not observe him saying anything, and I did not observe the crowd being a problem. I did advise LT ESCH of what I had observed and that I did not believe that there were any issues with crowd control at the scene or the other points of interest around Racine.

At approximately 2140 hours, LT ESCH contacted LT IDE and said that we were no longer needed to conduct rolling surveillance. At that point, I advised our team that we were no longer needed and we could end our tour of duty. It should be noted that the suspect, who was identified as KING, was driving a 2021 gray Volkswagen Atlas, Wisconsin registration **Sectors** This is a point to note because the Violent Crime Task Force at RAPD was provided information by SIU OFC SCOTT KELAND that he had a search warrant for that vehicle in relation to KING having firearms on his person while driving that vehicle. The search warrant was a valid search warrant and as mentioned, the day prior, myself, along with several RAPD Investigators and LT FREIDEL had been conducting a special assignment which was designed to do several things. One was to focus on areas of high shots fired incidents within the last four weeks. Another was to locate KING and his vehicle that had a search warrant on it. During our assignment, we did not locate KING or this vehicle. But, this is the same vehicle that OFC BRENNER had stopped that led to the OIS.

I gathered equipment and responded to the scene with MPPD INV. MARK HALEEN, who had also been working at the Special Investigations Office. Upon arrival on scene, I parked our vehicle on 12th St., Several Officers were in the process of securing the area through the use of crime scene tape. I was advised the location of the OIS was in a field in the 900 blk of Carroll St. INV. HALEEN and I walked to the 900 blk of Carroll St. where, I made contact with INV. KLINKHAMMER. INV. INV. KLINKHAMMER having seen the individual involved with this incident, through the use of a squad computer began searching for a photo of DASHONTAY KING in Phoenix records.

INV. KLINKHAMMER located a photo of DASHONTAY KING and it was verified that DASHONTAY KING was the individual involved in this incident.

I remained on scene and waited for clarification of the investigating agency. I was later requested to go Ascension ER as a large crowd had gathered at the hospital. INV. HALEEN and I responded to Ascension ER to assist as needed. I remained in the ER, and was not needed for security. I was released from the ER.
